Notification for Elections to the INASL Governing Council 2019

Nominations are invited for the posts of two Governing Council Members of the Association on the enclosed nomination form.

Completed nomination forms must reach **Prof. Anil Arora** (Add: A-3/192, Janakpuri, New Delhi - 110058, E-mail- dranilarora50@gmail.com) (immediate Past President, INASL and the Chief Electoral Officer), before 20th September, 2019 midnight. The candidates with valid nominations will be informed by email by 23rd September 2019. The last date for withdrawal of nominations will be 25th September 2019. Voting will begin at 09:00 AM on 26th September, 2019 till 05:00 PM on 10th October 2019. Counting of votes will be completed in time and result will be announced after one week. Eligibility to contest

Governing Council Member (2 posts). To be eligible for nomination for this post, the candidate must be an active Life Member of the Association in good standing for at least 3 years.

A candidate may apply for only one post on the Governing Council at one time.

A President of the Association who has also finished his term in the Governing Council as the Past President is not eligible for election to the Governing Council for 5 years from the date of expiry of his Governing Council membership.

Officers and members of the Governing Council shall have to reside in India during the tenure of their office.

Along with the nomination form, all candidates are required to submit a copy of their CV and a brief summary of the bio-data, not exceeding 250 words, for circulation to all life members. Canvassing in any form for or by candidates shall not be permitted and will disqualify the candidate from that election.

A member will be considered to be in good standing if he is not in arrears with any dues to the Association and is not facing any disciplinary action initiated by the Association. A member will be considered to be active if he/ she regularly attends and participates in the annual and/or mid-term meetings, attends General Body meetings and participates in INASL elections and postal ballots that are conducted from time to time on various issues by the Governing Council.
